Snow Removal Reminder (Bylaw No. 734)

PART 12  
SNOW, ICE  
AND DUST

(12.01) All persons with the Town of Stavely shall remove and clear away, within twenty four (24) hours, all snow, ice, dirt or debris and other obstruction from the sidewalk adjoining the premises owned or occupied by them and from the gutter.

Stavely Fire Department November fire safety tips:

DO YOU HAVE A PLAN?

More home fires occur in the months of November and December than at any other time of the year. This is mainly due to various ways of heating the home, Christmas lights and seasonal candles.

Therefore, it is very important for parents, teachers, and firefighters to teach children the importance of fire safety.

Most children learn about fire prevention and fire safety at school, but parents need to reinforce this information at home. When reviewing fire safety with your children at home, here are a few tips:

1. Draw an escape route for your kids on a piece of paper. Then go over the map of your house several times with escape routes highlighted. Show where exits are, such as doors and windows.
2. Fix windows that are stuck or painted shut. Make sure your child can open the window or door in every room.
3. Teach your child about smoke detectors and how they work. Let them hear the sound of the alarm so the child will recognize it and know what to do.
4. Teach kids how to touch the doors to determine if there is a fire on the other side. Explain when and how to get a wet towel and block the airway under the door or to put the towel over the hot doorknobs to escape.
5. When a real fire occurs, the smoke makes it hard to see. Children should know how to feel their way out of their house to get to safety. Make the practice fun by using a blindfold.
6. Decide on a meeting place outside of the home where everyone in the family should meet in the event there is a fire.

Carefully practicing these fire safety steps could mean the difference of life and death if there is a fire in the home.

JUNIOR FIREFIGHTER PROGRAM

A Junior Firefighter Program is now being offered!

This program was instituted for young men and women, aged 16-18, interested in preparing to become active firefighters upon reaching age 18.

A Junior Firefighter serves in a support role for the Senior Firefighters at actual emergencies as a supplement to a formal training program. Junior Firefighters attend regular fire practices. A Fire Officer serves as the Junior Firefighters Training Officer.

**Eligibility:** Any resident of the Municipality District of Willow Creek Emergency Services and the Stavely Fire Department response area, between the ages of 16-18, may make an application to the Stavely Fire department.

The applicant must be in good academic standing at their school at the time of application. A minimum GPA of 2.0 (C) must be maintained. A police background check with vulnerable sector check and provide 3-year drivers abstract Parental consent must be signed by a parent or legal guardian. The application must be approved by the Fire Chief.
